Our state-wide conservation priorities guide our interest in proposed bills. Bills that we are currently monitoring include the following:

CLIMATE/CARBON PRICING

- <u>SB 5127/HB 1555</u> Establishing a carbon pollution tax and investment program to reduce greenhouse gas emissions, facilitate the transition to a clean energy economy, and invest in K-12 education and other vital public services. SUPPORT
- <u>HB 1646/SB 5509</u> Promoting an equitable clean energy economy by creating a carbon tax that allows investment in clean energy, clean air, healthy forests, and Washington's communities. SUPPORT
- <u>SB 5385</u> Creating a fossil fuel carbon pollution tax, which would pay for the clean energy economy and other vital services. OPPOSE
- <u>HB 1372</u> Updating the framework for reducing greenhouse gas emissions in Washington based upon best available climate science. SUPPORT
- <u>HB 1144</u> Amending state greenhouse gas emission limits for consistency with the most recent assessment of climate change science. SUPPORT

CLEAN ENERGY

- <u>HB 1048</u> Promoting a sustainable, local renewable energy industry through modifying renewable energy system tax incentives and providing guidance for renewable energy system component recycling. SUPPORT
- HB 1334 Concerning the energy independence act. SUPPORT

- <u>HB 1249</u> Recognizing hydroelectricity as an eligible renewable resource in the energy independence act. OPPOSE
- <u>SB 5232</u> Allowing incremental electricity produced as a result of efficiency improvements to hydroelectric generation projects whose energy output is marketed by the Bonneville power administration to qualify as an eligible renewable resource under the energy independence act. OPPOSE
- <u>SB 5128</u> Allowing incremental electricity produced as a result of certain capital investment projects to qualify as an eligible renewable resource under the energy independence act. OPPOSE

FOREST HEALTH and FIRE RESILIENCY

- <u>SB 5546</u> Concerning proactively addressing wildfire risk by creating a forest health treatment assessment. SUPPORT
- <u>HB 1799</u> Utilizing cooperative agreements with the federal government, such as good neighbor agreements with the United States forest service, to advance forest health in Washington.
 SUPPORT

WATER RESOURCE CONSERVATION

- <u>SB 5024</u> Concerning groundwater supply availability in areas with ground and surface water interaction. SUPPORT
- <u>SB 5239</u> Ensuring that water is available to support development. OPPOSE
- <u>HB 1382</u> Establishing a rebuttable presumption that permit-exempt groundwater withdrawals do not impair instream flows or base flows. OPPOSE
- <u>HB 1348</u> Concerning the priority in the state water code assigned to various beneficial uses. OPPOSE
- <u>HB 1885</u> Clarifying the roles of state and local governments in the regulation and mitigation of water resources. OPPOSE

SAFE OIL TRANSPORT

- <u>HB 1611</u> Concerning oil transportation safety. SUPPORT
- <u>SB 5462</u> Concerning oil transportation safety. SUPPORT
- <u>HB 1210/SB 5425</u> Strengthening funding for oil spill programs in Washington by increasing revenue to the oil spill prevention account. SUPPORT
- NEW <u>HB 1135</u> Limiting oil spill contingency planning requirements to those railroads that haul oils used as fuel. OPPOSE
- *NEW* <u>HB 1136</u> Exempting short-line railroads that haul nonfuel oils from oil spill contingency planning requirements. OPPOSE

POLLUTION CLEAN UP

- <u>HB 1663/ SB 5501</u> Concerning imposing a surtax on the possession of hazardous substances. SUPPORT
- NEW <u>SB 5170</u> Concerning independent remedial actions under the model toxics control act. OPPOSE

HABITAT CONSERVATION

- <u>SB 5171</u> Concerning certain uses of state-owned aquatic lands. OPPOSE
- <u>HB 1009</u> Clarifying that the authority to mitigate environmental impacts under the state environmental policy act applies only to significant adverse environmental impacts. **OPPOSE**
- <u>HB 1008</u> Concerning the acquisition of land by state natural resources agencies. OPPOSE
- <u>HB 1103</u> Concerning the transfer of federal land to the state. OPPOSE
- <u>HB 1017</u> Addressing the siting of schools and school facilities. OPPOSE
- <u>HB 1597</u> Increasing revenue to the state wildlife account by increasing commercial fishing license fees and streamlining wholesale fish dealing, buying, and selling requirements. SUPPORT
